Artist-Gallery Consignment Agreement

2. This agreement applies only to works consigned under this agreement.
3. The artist reserves the copyright and all reproduction rights to these works. The gallery will not permit any of the artworks to be copied, or reproduced without any written permission. The gallery will print on each bill of sale: "The right to copy, photograph or reproduce the artwork(s) identified here is reserved by the Artist,"
4. Upon sale of the work(s), the artist will receive:
The final retail price minus a 25% commission to the Hollywood Sculpture Garden, and installation and removal fees (installation fee runs \$200 to \$500 depending on complexity/difficulty). If the sculptor decides to take the sculpture back before it's sold, he/she will be charged the installation and removal fee (to be collected prior to removal of sculpture).
5. If the artist wants to install and/or remove the sculpture by his/herself, he/she won't need to pay the installation fee. While installing the art, the installer will be responsible for proper installation. Every sculpture needs to be situated on a cement base that has a metal chain embedded into the cement to secure the art piece. If the installer causes any damage to any other sculptures and/or the Hollywood Sculpture Garden, he/she will be responsible for all damages.
6. If any artist acquires a lead from Dr. Robby Gordon or from showing in the Hollywood Sculpture Garden that produces a sale, we will require a 25% commission of the final retail price.
7. Hollywood Sculpture Garden displays the art in an outside facility. There are security camera on the premises however Hollywood Sculpture Garden will not assume any responsibility for any consigned work stolen or damaged.
8. Consigned works may not be removed from the premises for purpose of rental. Installment sales with a potential customer will be subject to artist permission. The specific retail prices may not be changed without the artist permission. The artist may withdraw my work(s) with a written notice.

9. All sculptures are in an open area and not insured. If the artist wants to insure them it is his or her responsibility. Artist is recommended to insure their art for their value. The type of insurance that the artist should get is called “Fine Art Floater” (this is the type of insurance that some of the artist have here).

10. The Hollywood Sculpture Garden will showcase your work for a period of 6 months. After this initial period has expired and the sculpture has not sold, you can apply for an addition 6-month period (subject to approval by The Board of The Hollywood Sculpture Garden). If The Board does not approve the additional time, it is the artist’s responsibility to arrange pick-up of works (we provide removal and delivery for a fee) as mentioned in paragraph number four of this contract. When the artist removes the sculpture, the installation fee will be due collected before removal of the sculpture.

11. Artist does not hold Dr. Robby Gordon and or The Hollywood Sculpture garden liable for any damage or loss sculptures from any casualty while art is in possession or on exhibit.

12. Artist will be responsible for delivering and picking up all art works, including remaining artwork after consignment period.

13. Shipping costs for the art piece from outside the U.S. mainland are to be covered by *The Hollywood Sculpture Garden* at a rate of 50%; the shipping fee is to be deducted upon sale of the art piece. Should the sculptor want his piece shipped back prior to an official sale, the sculptor is responsible for covering the full shipping fees, return shipping included.
